CALL FOR ENTRIES:

The P I T T S B U R G H **Society of Artists** is proud to present our
FIFTY-THIRD ANNUAL Exhibition at **The 3rd Street Gallery** in Carnegie.
This will be a non-themed exhibition that will showcase the very best work of
the P I T T S B U R G H **Society of Artists**.

ELIGIBILITY:

- This exhibition is open to all current and paid PSA members.
- Please update membership at: www.pittsburghsocietyofartists.com.
- Online registration is required. Late and/or unregistered artwork will not be accepted.
- Artists may enter up to two (2) pieces (except film, video or installation) for the juror's consideration.
- Pieces that have more than one part, such as a diptych, should be priced for the amount of the whole piece. Parts will not be sold separately.
- Entries can be two or three-dimensional and must be exhibit ready (including all mounting hardware.) Work must be original and new, created within the past two (2) years, and not exhibited previously within a 150-mile radius of Pittsburgh.
- All work must be for sale.
- Exhibitors are expected to transport their work to and from the gallery.

JUROR: Nicole Capozzi

Nicole Capozzi was born in Pittsburgh Pennsylvania and studied close to home at Carlow College (now Carlow University). She earned her BA in 1998, focusing primarily on painting. In 2001, Capozzi opened BoxHeart Gallery with her husband, abstract painter Joshua Hogan. As a gallery owner in Pittsburgh's east end for 15 years, Capozzi has curated, coordinated, and hosted over 200 exhibitions for regional, national, and international artists providing an outlet for conceptually engaged and aesthetically resolved exhibitions that both reflect contemporary art issues and are relevant to the community.

ENTRY GUIDELINES AND INFORMATION:

- Artist must be a current and paid member of PSA.
- The artist **MUST** register on-line prior to the date of drop off at: **www.pittsburghsocietyofartists.org**.
Unregistered work will not be accepted at drop-off.
NO EXCEPTIONS!
- Artists may enter up to two (2) pieces (except film, video or installation) for the juror’s consideration.
- Work must be original, not executed under instruction and available for exhibition if selected (no substitution). Work must have been produced within the last two (2) years and may not have been exhibited within 150 miles of Pittsburgh. All work must be for sale. Works marked NFS will not be considered.
- 2D pieces must be exhibit ready, professionally presented and ready to hang (no sawtooths please).
- 3D works must be exhibit ready, and come with clear presentation instructions.
- Actual work must be hand delivered to the **3rd Street Gallery**, 220 3rd Street, Carnegie PA, 15201 for the jury process by Saturday, November 3, 2018 or Sunday, November 4, 2018 from 11:00 am to 4:00 pm. Please refer to the calendar on side column.
- Artists not selected for the exhibit will be notified by email and must pick up all work not chosen for the exhibition on Wednesday, November 7, 2018 from 11:00 am to 4:00 pm.
- All works must have a tag attached to the back of your work upon delivery.

FEE:

Members only - \$20.00. You will pay your non-refundable entry fee during registration online. If you are unable to pay online, your registration fee will be collected at drop off.

AWARDS:

Three juror’s awards will be presented at \$200.00 per award.

LIABILITY AND SALES:

Submission of work for the **FIFTY-THIRD ANNUAL** Exhibition exhibition, shall constitute an agreement on the part of the artist to comply with the conditions set forth in this prospectus, including the following:

- Work is to be delivered to the **3rd Street Gallery** on Saturday, November 3, 2018 or Sunday, November 4, 2018 from 11:00 am to 4:00 pm.
- Artist has the duty to check dates of delivery and exhibition before applying.
- No substitutes will be accepted for work selected.
- Selected work must be on view for the duration of the exhibit. No work may be withdrawn prior to close of the exhibition.
- All reasonable care will be taken with the work but insurance is responsibility of the artist. The **3rd Street Gallery** and **PSA** will assume no liability for damage or loss.
- Selected artists agree to allow work to be photographed for media use, for educational and publicity purposes.
- Artists receive 100% of the sales price of work that is sold.
- **Gallery sitters will be needed. If work is accepted, members will be asked to gallery sit for five hour shifts, Thursday 11 to 4pm, Friday 11 to 4 pm, and Saturday 11 to 4pm. for the duration of the exhibit.**
